





JUNE ISSUE SPONSOR

So if you enjoy the newsletter and would like to mark that in some way then I would be delighted to hear from you. Sponsorship costs just £20 per issue.

As the UK number of coronavirus related deaths approaches 40,000 and the lockdown rules are eased a little, thoughts turn to a time of normality and bowling when we like. Seems that we are some way off a full return to competitive bowling but there is some light at the end of the tunnel.

Groups of six being allowed to meet outdoors from 1 June. Outdoor markets and car showrooms reopening; professional football returning to action from 17 June albeit without spectators and dentists are back in business. Garden Centres and some shops are also being allowed to open but with strict social distancing rules applying.

Yet we have to ask the question if the rules were suddenly relaxed for a July return to League bowling how many of our bowlers would be comfortable in doing so? With our age group we are likely to be the last allowed to return to a normal life but will we be in a rush to resume full contact with strangers? Many of our bowlers also have other health-related conditions which will inevitably make them wary of contact with others.

In our favour is that our sport is played outdoors and such sports, like football, are seeing movement towards a resumption in some form. So we may have the opportunity to bowl competitively again soon even if we can't have access to toilets and the clubhouse for a half-time piece of bread n' drip. That in itself will make it a no-go situation for some bowlers although green-side bushes could get an extra 'watering' on match days as an alternative.

A new poll is appearing soon on the HDVBA website to ask bowlers if they are ready to return to competitive bowling. We want to test out the mood of bowlers ahead of a resumption of competitive bowling. Are we ready to bowl or not? Do teams know how many of their bowlers are waiting for the call and how many are dreading it? Will your team have a full complement of bowlers if we get a July go-ahead?

The Post-Pandemic Poll asks seven questions about bowler's personal thoughts on when they will feel ready to return to competitive bowling. It is totally anonymous and you can skip any questions you don't fancy answering. The outcome could give an indication of the state of readiness to return to action of our bowlers. It could influence the decision on the resumption of bowling in our Leagues.

I am sure that many will be keen and ready to resume bowling but also fear that a surprising number may be more cautious of the risk to their own, and their family's, health.

OPENING UP YOUR GREEN THE BCGBA GUIDANCE

The Government advice is that bowling clubs can open from 13 May as long as they adhere to the guidance they issued at the time. This is reproduced below and should be followed by all clubs deciding to open their club greens to members.

Phase 1

Limited Green Opening, Exercise and Practice (Full Social distancing must be maintained 2 metres distance)

- During Phase 1 only 1 group permitted on the green at a time Bowling Greens can re-open, but you should only partake alone, or with members of your household, or with one other person from outside your household, while practising social distancing.
- Club Schedule of Attendance (names, dates & times must be recorded) produced to ensure limited attendance should be maintained (record of green availability should be maintained) Club to appoint a central contact (To enable track and

trace records should this be required)

- Only Club members allowed on a Green
- Ensure that your Insurance cover is up to date, Endsleigh Cover is dependant on membership of BCGBA (club fee £35.00)
- Each Club will have to make their own assessment of the safety in opening your green
- Arrangements should be made to manage the social distancing and all other hygiene procedures
- You will need to ensure you have your landlord's permission to open the green if this applies
 Maintenance schedule will need to be reviewed to ensure green is available for play prior to opening
- Club Buildings and toilets to remain closed, will be reviewed as part of phase 2/3

The Opening of Greens GUIDANCE FOR INDIVIDUALS:

- Only use your equipment brought from home (jacks, mats, bowls etc.)
- Sterilize equipment before and after use
- Keep strict social distancing measures in place you must remain at a safe distance (2 metres) from people outside of your household

- Follow strong hygiene practices at every opportunity - wash your hands when you get home
- You must have permission from your club to use the green
- Your club will have an agreed process for you to agree a time for you to access the green
- Once you have completed your session, please depart as soon as you safely can to enable others to access the green.
- You may only play on green if you are a member of the club

DO NOT:

- Do not enter clubhouse, or any facility which is part of the club (including toilets)
- Do not use club equipment Do not organise any competitive bowls.
- Do not turn up at the green without prior agreement from your club

THINGS TO THINK ABOUT:

- Being careful about touching solid surfaces e.g. gates, seating, doors, etc.
- Wash your hands as soon as you get home, avoid touching your face and take hand sanitiser with you to use while out if possible

NOTE FOR CLUBS:

• Your Club most have written authority from the landlords of the green that you can gain access to the green under the strict guidelines laid out in this

document and then follow all guidelines

- It is the clubs' responsibility to decide if your facility is open.
- Please check that your insurance is valid
- You must have a clear process for knowing who Is playing at the green, make this as clear as you can for your club members to understand and abide by.
- Please place a sign in clear view of all visitors of the guidelines set out above.
- Do not use clubhouse and any toilet facilities connected with the Club, ensuring there is clear signage to state this
- Do not use club equipment



IS YOUR GREEN OPEN NOW?

Thank you to all the clubs that have shared with us the latest information about the availability of their greens to their members.

We have received regular updates from many clubs and not only those with teams in the Veteran's League.

The listing alongside represents the position as on Friday 29 May and regular updates are always available on the HDVBA website.

Our table alongside indicates that we have records for 37 local clubs and 25 of those are now open for members to visit and enjoy some practice or social bowling.

A number of clubs are operating booking systems so reducing the number of wasted journeys of members travelling to their green only to find it already having the maximum number of bowlers on the green.

You can enjoy some limited bowling as long as you follow the BCGBA guidance which is there to make it safe for you and members of your household. It is in your own interests to stick with that guidance at all times.

DID YOU KNOW THAT ...

...there was once a bowling green on Castle Hill? It is on Town Maps from 1850 until early 1900s. Did you also know that it wasn't the highest green in the area at that time? You need to visit the HDVBA website to the see the answer to that one.

'BEST FOR' CLUB SURVEY

During the past month we undertook an online survey of our clubs. Members could register for their favourite clubs (excluding their own) in eight different categories. It was just for fun but it generated quite a bit of local interest.

The format being that in Stage 1 of the survey voters could nominate any Veteran's League club in each of the eight categories. Then for Stage 2 the top four selections in each category were matched against each other with another round of voting.

The full sets of results from both stages are alongside. The figures in red and in brackets are the positions and vote percentages are all from Stage 1. The others being the final Stage 2 scores.

So in the Best Green category Lindley BC came out top in Stage 2 with 33% of the 59 votes cast. Outlane finished fourth even though in Stage 1 they were equal first along with Lindley BC. Fourth out of 47 is no disgrace of course.

The only category where the voting was unchanged between Stage 1 and Stage 2 was the final one on 'Most Challenging Away Green' with the finishing order unchanged throughout.

I have noted that the bread and dripping brigade feature prominently in the Best for Refreshments category It was also pleasing to see a number of our smaller clubs featuring among the shortlisted ones in several categories through to Stage 2.

Even though it was just a bit of fun I am sure that the winners took great satisfaction from their achievements and so they should.

£10,000 GRANT FOR CLUBS

We are aware of a number of clubs that have successfully applied for their small business support grants from Kirklees MC which they are entitled to as part of the Government's aid package during the coronavirus lockdown.

Any club with a combined (green, clubhouse, car park) rateable value of less than £15,000 is entitled to a grant of £10,000. This is available to all clubs upon application. The link to the paperwork is on the HDVBA website. It is a fairly straight-forward process with receipt of the grant taking about 4-5 weeks from application.

Any club with a rateable value of above £15,000 is entitled to a grant of £25,000. There are just the two levels of support. These are difficult times for many bowling clubs with no bar revenues to supplement membership fees so make sure your club has submitted their application.

MANAGEMENT COMMITTEE MEETING REPORT

Notes from the Management Committee meeting held on Monday 11 May 2020 This meeting was held by a Telephone Conference Call service with 11 members joining in

The meeting began with a short moment of silence for members in respect for the recent passing of our President John Hoyle and other bowlers from our Leagues.

The position of President was discussed with quick agreement that Vice-President, Allan Dobson, would take over the top position. It was further agreed with the special circumstances of this season that he would assume the position of Acting President in 2020 and then move into the full President role from the 2021 AGM for a full two-year term of office from then. There was no current interest from any of the other members present of being considered for the now vacant position of Vice-President. It was agreed to leave the matter on the table for the immediate future but members were of one mind that the next Vice-President (and President-elect) should come from the Management Committee if at all possible.

Alan Sharpe was confirmed as the Away Team Manager of our Inter-District Team and will succeed John Hoyle in this position.

It was agreed that the scheduled end-of-season Anniversary Presentation Event should be cancelled. With little likelihood of any competitive bowling this season there would be no trophies to present so the event would be pointless. Should there become a need to present any award to any team or individual in 2020 then this would be included in the 2020 Half-Year General Meeting in October as has been past practice. The Presentation Event had been scheduled to be held at Rastrick on Monday 2 November and this booking has now been cancelled.

The Treasurer took the opportunity in his Report to remind clubs that grants were now readily available for bowling clubs from Kirklees MC and Sport England to offset the financial damage of the coronavirus pandemic. Various amounts are available from the Sport England Emergency Fund depending on the claimant's circumstances. The funding available from the Government via the Local Authority was more regimented and determined by the rateable

value of the club's green and/or clubhouse. Up to a rateable value of £15,000 meant that a grant of £10,000 was available upon application. Where the rateable value exceeded £15,000 then a grant of £25,000 was available. Full details, including the KMC application form, have been and still are on the HDVBA website.

The Competition Secretary reported that he had managed to get some more of the Anniversary scorecards and mugs united with their respective clubs but three clubs remained outstanding and probably would do so until the current lockdown situation had eased.

The League Secretary reported that he had received correspondence from both of John Hoyle's sons on different matters. The family asked if it would be in order for the HDVBA Chain of Office to be placed on John's coffin during the service planned for 12 May. Members were pleased to confirm that they supported this gesture. In addition, the family had also asked if there were any objections to them instructing a trophy maker to make them a copy of the aforesaid Chain of Office as a permanent reminder to them. Again the Management Committee had no objections. The family are also keen to arrange an event to commemorate John's involvement in bowling in the area. Initial thoughts involve arranging a one-off knock-out competition to be held over a weekend or alternatively donating a trophy to the HDVBA for them to allocate to a competition and become a perpetual reminder of John's time in bowling. The family are to discuss the options between themselves before coming back for further discussions.

The impact of the Prime Minister's televised address on the previous evening had left members with much food for thought but also a recognition that they could not start to plan the consequences of the theme of this address until the details are published. That was expected to be later on the day of this meeting and members were prepared to meet again should the need arise to make any arrangements for a change in circumstances.



The next meeting of the Management Committee is a Conference Call Virtual Meeting at 10am on Monday 8th June 2020



40 YEARS AGO JUNE 1980

The HDVBA Minute Book reports on an Inter-City competition being held at Greenhead Park in June 1980. It is not clear what that competition was as the Yorkshire Inter-District didn't start until 1992 and the Hickson Trophy started up in 1989. Maybe someone can throw some light on to that. The Huddersfield squad was comprised of 20 named bowlers and two reserves, namely:

P. Ellis (Captain), S Swift (Vice-Captain), CB Armitage, A Smith, JW Addy, A Simpson, G Lockwood, G Martin, W Senior, J Wilkinson, S Hemingway, H Ives, F Barlow, GA Hirst, L Laycock, H Bye, F Sheard, JW Cliffe and R Machen. Reserves: C Hirst and Lew Taylor.

Within a week the squad changed a lot as a number of players withdrew and the Captain and Vice-Captain.both asked to stand down from these roles but were happy to remain in the squad. As a result W Senior was elected Captain and JW Cliffe made Vice-Captain with J Liversidge and T Clayton added to the numbers.

5 YEARS AGO JUNE 2015

The League Tables at the beginning of June 2015 saw Lockwood Con leading the way in the top Sections of both the 10-man and 6-man competitions. Whilst they managed to retain that position in the 10-man all season they were overtaken by Longwood in the 6-man.

Newsome kept top of Section B to take that title but in Section 2 of the 10-man leaders Almondbury BC A faltered and failed to win promotion and Broad Oak conceded the Section 5 title to Golcar Lib B who opened up a 25 point lead over the rest. The other three table leaders at this point, Lockwood Con, New Mill A and Lindley Lib B, all went on to claim their respective titles.
